The Disciplinary Board of the Supreme Court of Pennsylvania District II Office is located in Trooper in suburban Philadelphia approximately 25 miles northwest of Center City Philadelphia and just a few miles north of King of Prussia, where the Pennsylvania Turnpike, Interstate 76 and 276, and U.S. Routes 202 and 422 intersect.

**From Harrisburg and Pennsylvania Turnpike**

Take Exit 24/326-Valley Forge. Make sure you are in the far right lane. After proceeding through the tollbooth, take exit marked U.S. Route 202 South-West Chester. Once on Route 202 South, travel past the first exit to Swedesford Road-Route 422 and take the exit marked U.S. Route 422 West-Pottstown. Travel west on Route 422 for 3 miles and exit at PA Route 363 North-Audubon/Trooper. Proceed north on Trooper Road for 1.2 miles until you reach Eisenhower Avenue (which is 0.2 miles past the second traffic light). Turn left onto Eisenhower and proceed 0.4 miles directly into the parking lot of the Disciplinary Board.

In front of you is our building 820 Adams Avenue. There is a big parking lot with three flags. The building is 2-story with glass and brick. We are on the 1st floor, Suite 170, door on the right of the lobby.

**From Media area and West Chester**

Take 252 North to Route 202 north to Route 422 West. Get off at the 3<sup>rd</sup> exit marked for Route 363, Audubon & Trooper. Bear right on the ramp, it will become Trooper Road. Proceed north on Trooper for 1.2 miles until you reach Eisenhower Avenue (which is 0.2 miles past the second traffic light). Turn left onto Eisenhower and proceed 0.4 miles directly into the parking lot of the Disciplinary Board.

In front of you is our building 820 Adams Avenue. There is a big parking lot with three flags. The building is 2-story with glass and brick. We are on the 1st floor, Suite 170, door on the right of the lobby.

**From Norristown**

Take Main Street West across the train tracks and go about 2.5 miles to Egypt Road. Turn left on Egypt and then left again on Trooper Road (Rte 363). Pass Valley Forge Beef and Ale Tavern on the right, at the next road, turn right onto Eisenhower Road. Look for sign – Valley Forge Corporate Center. Go straight on Eisenhower until it dead ends at Adams Avenue.

In front of you is our building 820 Adams Ave. There is a big parking lot with three flags, the building is 2-story with glass and brick. We are on the 1st floor, Suite 170, door on the right of the lobby.

### **From Center City**

Take 76 West (Schuylkill Expressway) to 202 South to 422 West. Get off at the 3rd exit marked for Route 363, Audubon & Trooper. Proceed north on Trooper Road for 1.2 miles until you reach Eisenhower Avenue (which is 0.2 miles past the second traffic light). Turn left onto Eisenhower and proceed 0.4 miles directly into the parking lot of the Disciplinary Board.

In front of you is our building 820 Adams Avenue. There is a big parking lot with three flags, the building is 2-story with glass and brick. We are on the 1st floor, Suite 170, door on the right of the lobby.

### **From Bucks County**

Take the Turnpike to the Valley Forge Interchange or follow Route 202 South past King of Prussia to Route 422 West. In each case follow directions under Harrisburg and Pennsylvania Turnpike.

### **From Scranton and Allentown**

Go South on Northeast Extension of PA Turnpike (PA Rte 9/Interstate 476) to West on PA Turnpike (Interstate 276) to Valley Forge Exit (24/326) and follow Harrisburg and Pennsylvania Turnpike directions.

### **From Reading-Pottstown- Pottsville**

Take Rte 422 East to Oaks Exit (Next exit after Collegeville, Route 29). Take Egypt Road East (Right turn bottom of ramp). Note there is no Trooper Road Exit in this direction. Continue east on Egypt Road through Audubon to Trooper Road, about 3 miles. Take the hard right on Trooper Road, Route 363 and pass the Walmart on the left. Pass Valley Forge Beef and Ale Tavern on the right, at the next road, turn right onto Eisenhower Avenue. Look for sign – Valley Forge Corporate Center.

In front of you is our building 820 Adams Avenue. There is a big parking lot with three flags. The building is 2-story with glass and brick. We are on the 1<sup>st</sup> floor, Suite 170, door on the right of the lobby.
