



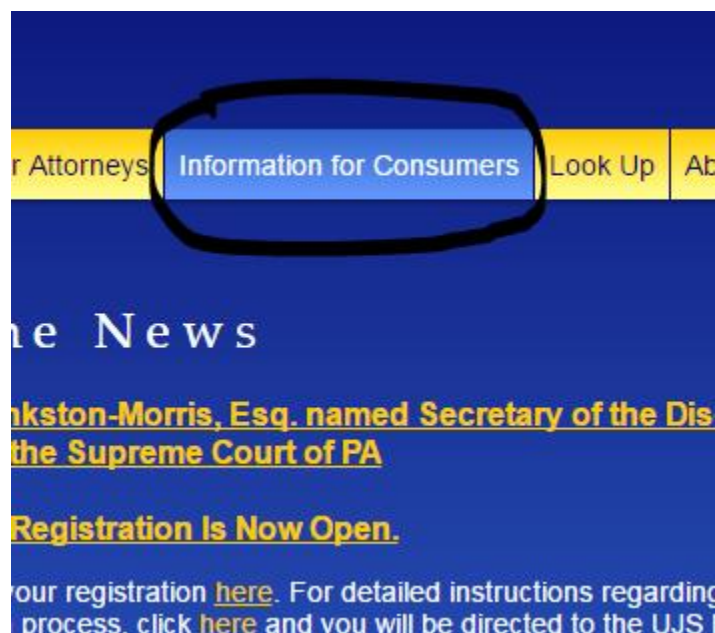

Steps to File a Formal Attorney Complaint

Locate, print and complete appropriate Complaint Form

- Identify your attorney (most likely, this is known information)
- Go to www.padisciplinaryboard.org

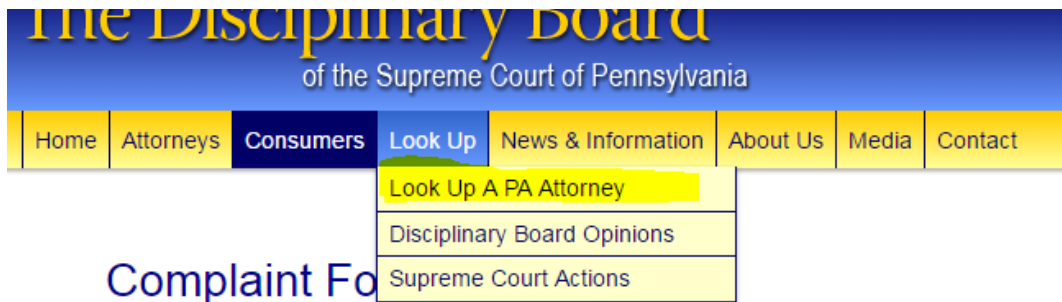
